RISK WARNING:

Roller Derby activities can be inherently dangerous and serious accidents can and do happen. I acknowledge that my minor child is exposed to certain risks during adult Roller Derby skating activities including but not limited to falling, crashing into another person(s), being physically or mentally injured, impaired, maimed or killed and my property may be damaged lost or destroyed. I declare that I have voluntarily read and understand this warning and accept and assume the inherent risks in adult Roller Derby skating activities.

RELEASE AND INDEMNITY: In consideration of Skate Victoria accepting my permission for my minor to participate in adult Roller Derby activities, to the extent permitted by law:

- 1. Release and will release Skate Victoria (and any of its Roller Derby Clubs) from all actions, suits, proceedings, claims, demands, losses, damages, penalties, costs and expenses however arising, including but not limited to negligence, that the minor child have or may have had but for this release arising from or in connection with their membership and /or participation in any Skate Victoria authorised or recognised adult Roller Derby activity; and

Indemnify and will keep indemnified Skate Victoria (and any of its Roller Derby Clubs) in respect of any actions, suits, proceedings, claims, demands, losses, damages, penalties, costs and expenses by any person arising as a result of or in connection with the minor's membership and/or participation in any adult Roller Derby activities.
